UPON the N244 Application Notice of the Claimant for summary judgment against the First Defendant dated 21 September 2023

AND UPON hearing counsel (Andrew McGuinness) for the Claimant and none of the Defendants being present or represented

AND WHEREAS the Claimants and Second and Third Defendants have settled these proceedings by way of Tomlin Order and confidential Agreement dated 11 August 2024

AND WHEREAS the Claimant acknowledges and gives full credit for all payments received from the Second and Third Defendants pursuant to the said Tomlin Order and confidential Agreement, and will give credit for all such future payments

AND WHEREAS this Order is subject to and with credit given for all and any future payments received from the Second and Third Defendants (at the date hereof £16,000) pursuant to the said Tomlin Order and confidential Agreement in discharge of the joint and several liability of all Defendants

IT IS ORDERED that :-

1. The First Defendant shall pay to the Claimant the sum of £72,000.
2. The said sum of £72,000 shall bear simple interest at the rate of 8% per annum from and including 18 October 2022, being the date of the Letter of Claim herein, to and including 27 August 2024 (being the date of the first

part-payment in the total sum of £16,000 being paid by the Second and Third Defendants and a period of 1 year and 314 days) in the sum of £10,840.45.

3. The sum of £56,000 (being £72,000 minus £16,000) shall bear simple interest at the rate of 8% per annum from and including 28 August 2024, being the day after part-payment of £16,000 by the Second and Third Defendants, to and including 27 November 2024 being the date of this order (a period of 91 days) in the sum of £1,116.93.

4. The sum of £56,000 shall bear simple interest at the rate of 8% per annum (£4,480 yearly) from and including 28 November 2024 to date of payment (daily rate of £12.27).

5. At the date hereof the total payable by the First Defendant to the Claimant is  $£56,000 + £10,840.45 + £1,116.93 = £67,957.38$  and continuing at the rate (8% of £56,000 per annum) of £4,480 per annum or £12.27 per diem.

6. The First Defendant shall pay the costs of the action summarily assessed in the sum of £40,114.92 inclusive of VAT.
